The Shapiro property on OCR

At this time there is a tentative agreement with the owners and developers of the "Shapiro property" directly across from the Stevenson Crossing Homeowner Association. The agreement has not yet been finalized or recorded. It calls for the number of dwellings to be no more that 46, placed further from Old Court Rd (OCR) with more landscaping, wider entry, and no further development using un-used density. This means the property will be developed at below DR1 although it qualifies at DR2. This agreement came thru the work of the PGCC Shapiro committee of which OCGS was an active member. Quarry Lake at Greenspring

1. The pending additional north bound lane on Greenspring is under construction. Hopefully it will be completed by the end of 2008. 2. The Quarry now has public bus service. The MTA will determine by the end of the year if ridership is sufficient to continue service. There are at least 3 stops along the commercial area.

Traffic Safety Concerns

The State Highway Administration has not supplied us with requested accident reports for the OCR/Greenspring intersection and reports for OCR from Park Heights to Falls Rd for the years 2006- 2007. Our web site posts the accident reports . The reports are in .pdf format and can be viewed on line or downloaded. At present the data covers accidents from 2003-2005 only. I would not be surprised if the totals were higher, thus the delay.
