This year's meeting will again host speakers from The Courts of Hidden Waters now under construction along Old Court Road west of Greenspring Avenue and from Hidden Waters Farm. Hidden Waters Farm & The Courts of Hidden Waters

The president, vice president, past president and newsletter editor were treated to a guided tour of the Farm late last year. It is a very impressive operation. The Schons have planted two bags of milkweed and are hopeful they will grow along the east side of Branchwood off the Old Court Road corner on their new meadow to attract Monarch butterflies and help sustain them on their travels. Plantings of wild flowers will also continue this spring within the meadow.
